


This season also marks the debut of our new website. It provides both readers and authors with a modern interface and straightforward navigation of our lists and textbooks.



The British Royal Family and the intelligence community are two of the most mysterious and mythologized actors of the British State. *Crown*, *Cloak, and Dagger* offers a new history of how the two have been inextricably linked from the reign of Queen Victoria to the present.

Richard J. Aldrich and Rory Cormac unveil a wealth of archival detail that changes our understanding of the role of the monarch in politics, intelligence, and international relations. Successive queens and kings have all played an active role in steering British intelligence, sometimes against the wishes of prime ministers. Even today, the monarch receives "copy No. 1" of every intelligence report. Attempted assassinations and kidnappings, the abdication crisis, world wars and the Cold War, and the death of Princess Diana are just some of the topics covered in the book.

Fascinating and fast-paced, *Crown*, *Cloak*, *and Dagger* demonstrates that the British monarch continues to be far more than a figurehead. This book will inform as well as entertain anyone with an interest in history, espionage, and the royals.

QUESTION AND ANSWER WITH THE AUTHOR

How important is the monarch's position in the British government? Are there inherent problems when one person has that much access to government information?


Every Tuesday afternoon the prime minister and the monarch meet and what is said there has remained deeply secret; it often concerns spies, sabotage, and security, and it's uncovered for the first time in this book. Queen Victoria began a tradition of informal and private secret service focused on the royals. We argue that this sort of information is power, and therefore Britain is not so much a democracy but instead remains a monarchy—one in which all institutions still venerate the Crown.

What is one of the most surprising things you learned while researching for this book?

We were amazed to learn how often fanatics, spies, and terrorists have attempted to assassinate the British head of state, concocting the most outrageous plots. This is why the monarch loves the intelligence services—quite simply, because they help to keep them alive!

How do you see the monarch's role in the British intelligence system evolving over the next few years?

Intelligence and security around a ruling monarch is always difficult, but this subject becomes much trickier when people try to leave the royal family. Edward VIII; Diana, Princess of Wales; and now Prince Harry all present fascinating examples. So the story of Crown, Cloak, and Dagger will run and run.

"Let Us Go Free" Slavery and Jesuit Universities in America

C. WALKER GOLLAR

A DISQUIETING NARRATIVE OF JESUIT SLAVEHOLDING AND ITS HISTORICAL RELATIONSHIP WITH JESUIT UNIVERSITIES IN THE UNITED STATES

The Society of Jesus, commonly known as the Jesuits, is renowned for the quality of the order's impact on higher education. Less well known, however, is the relationship between Jesuit higher education and slavery. For more than two hundred years, Jesuit colleges and seminaries in the United States supported themselves on the labor of the enslaved.

"Let Us Go Free" tells the complex stories of the free and enslaved people associated with these Catholic institutions. C. Walker Gollar shows that, in spite of their Catholic faith, Jesuits were in most respects very typical slaveholders. At times, they may have been concerned with the spiritual and physical well-being of the enslaved, but mostly they were concerned with the finances of their plantations and farms. Gollar traces the legacies of the Jesuits' participation in the slaveholding economy, portrays the experiences of those enslaved by the Jesuits, and shares the Jesuits' attempts to come to terms with their history.

Deeply based on original research in Jesuit archives, "*Let Us Go Free*" provides a vivid and disquieting narrative of Jesuit slaveholding for the general reader interested in the historical relationship between slavery and universities in the United States.

C. WALKER GOLLAR is a professor of church history in the Department of Theology at Xavier University in Cincinnati. He specializes in the history of American Catholicism. He is the author of *American and Catholic: Stories of the People Who Built the Church* (2015).

QUESTION AND ANSWER WITH THE AUTHOR

In your introduction you state, "despite the incredible injustice of slavery, this forced system did not and could not erase the fundamental humanity of those persons enslaved." In what ways does your book confront the attempted erasure of enslaved people's humanity?


In "Let Us Go Free" I confront historical attempts to erase enslaved people's humanity by showing that individuals enslaved by Jesuits formed relationships, created families, worked hard, loved God, and made the world a better place in many ways, including by enabling Jesuits to build numerous colleges.

What do you wish more people knew today about the history of Jesuit slaveholding?

I wish more people knew that Catholics and Jesuits were much more than merely passive participants in the legal institution of slavery. Catholics tended to own more enslaved people than their non-Catholic neighbors, while Jesuits often stood among the largest of slaveholders. At the same time, persons held in slavery by Jesuits frequently were acclaimed for their outstanding Catholic faith. In other words, some enslaved Catholics, even more than free people, may have better understood what it meant to be authentically Catholic.

What do you see as the role of Jesuit universities today in reckoning with the past? What has been done, if anything, that deserves credit? What should be done going forward?

Jesuit universities have begun to confront modern-day racial inequalities by publicly acknowledging historical connections between Jesuit schools and slavery. This acknowledgment has prompted many difficult conversations, scholars have begun to face the past in brutally honest ways, and descendants of enslaved people have been given new opportunities to share their stories. These efforts must continue. To further address the injustice of the past, Jesuit universities must also extend additional opportunities for more Black people to pursue higher education.

Unlike individuals or corporations that become insolvent, nations do not have access to bankruptcy protection from their creditors. When a country defaults on its debt, the international financial system is ill equipped to manage the crisis. Decisions by key individuals—from national leaders to those at the International Monetary Fund, from holdout creditors to judges—determine the fate of an entire national economy. A prime example is Argentina's 2001 default on \$100 billion in bonds, which stands out for its messy outcomes and outsized impact on sovereign debt markets, sovereign debt law, and IMF policy.

Default is the riveting story of Argentina's sovereign debt drama, which reveals the obscure inner workings of sovereign debt restructuring. This detailed case study describes the intense fight over the role of the IMF in Argentina's 2005 debt restructuring and the ensuing bitter decade of litigation with holdout creditors, demonstrating that outcomes for sovereign debt are determined by a complex interplay between financial markets, governments, the IMF, the press, and the courts.

This cautionary tale lays bare the institutional, political, and legal pressures that come into play when a country cannot repay its debts. It offers a deeper understanding of how global financial capitalism functions for those who work in or study debt markets, international finance, international relations, and international law.



History demonstrates that when the virtue of humility is cast aside, excessive individualism follows. A person who lacks humility is at risk of developing a deceptive sense of certitude and at worst denies basic human rights, respect, and dignity to anyone they identify as the enemy.

Humility, a cultural history and biography of the idea of humility, argues that the frightening alternative to humility has been the death of civility. In this book, Bellitto explores humility in Greco-Roman history, philosophy, and literature; in the ancient and medieval Jewish, Christian, and Muslim scriptures and sermons; in the Enlightenment; and in contemporary discussions of education in virtue and citizenship. The author encourages readers to recover and reclaim this lost virtue by developing a new perspective on humility as an alternative to the diseases of hubris, arrogance, and narcissism in society.

This book offers a fresh perspective on this lost virtue for readers concerned with the culture wars and those interested in finding a path to renewed civility.

CHRISTOPHER M. BELLITTO is a professor of history at Kean University in New Jersey, where he teaches courses on ancient and medieval history. He is the author of ten books and also serves as series editor in chief of Brill's Companions to the Christian Tradition and as an academic editor at large for Paulist Press.

QUESTION AND ANSWER WITH THE AUTHOR

How does humility work with the other virtues?

Think of humility as a base or center point: the hub of a wheel out of which other virtues radiate—it's a disposition, a fundamental posture. That humble stance provides discretion, perspective, and proportion.

Humility promotes moderation. Moderation slows conversations down, gives closed minds and cold hearts a chance to pause, and can build consensus. Humility and moderation can force us to look at our own prejudices, biases, stereotyping, sprints to condemnation, and desire for total victory. We can find that other ideas and needs have merit, too, even if I may not like them. I don't have to agree totally, but a political conversation that takes the best options from among several competing ideas and avoids their worst elements can help build a more perfect union.


As modern society is increasingly infected by "me-ism," how does humility serve as the antidote?

By choosing to be humble, we're choosing to be upset, disturbed, confronted. We start with the premise there's more we don't know. That attitude makes it easier to steer a course correction while it also promotes persistent curiosity. Humility helps us restore the idea that there is yet something to be learned from somebody else. It gives you an out. The very act of interaction is a step toward building community with a shared sense of purpose in righting wrongs instead of winning.

What's the risk of not having humility?

Without humility, there can be no honor. Never expect honor from people without shame. Don't expect empathy from such people, either. That empathy gap is a serious hole in our communities today. It's robbed us of our humanity.

The antidote: humility's time has come again.

THE REMARKABLE ARCHITECTURAL AND SOCIAL HISTORY OF DC'S MULTIFACETED ALLEYWAYS

Alleys in Washington, DC, have always been a fundamental part of the city's life and economy. Deliberately hidden from public view by the capital's early planners, DC's alleys were created to provide access to stables, carriage houses, and other utility buildings. But as the city grew and property values rose, the nature of some alleys and their buildings changed, resulting in a parallel world of residential, manufacturing, and artistic spaces. Kim Prothro Williams reveals this world in a fascinating and richly illustrated history.

In the nineteenth and early twentieth centuries, the city's inhabited alleys were often unsanitary spaces that were home to its poorest residents. These conditions spurred Progressive Era campaigns to demolish alley dwellings, which in turn led to the displacement of minority and disadvantaged communities. Today, many remaining alleyways, with their intimately scaled buildings, have been transformed into vibrant commercial and residential spaces. Yet this new wave of development raises questions about how spaces that were once reserved for the city's poorest residents now cater to the wealthy.

This book is a must-have for anyone with an interest in Washington, social history, architecture, or historical preservation.






A JESUIT PRIEST'S MEMOIR ABOUT RECOVERING HIS MEMORY OF CLERICAL ABUSE AS A CHILD AND HIS SUBSEQUENT HEALING JOURNEY

In October 2021, the Independent Commission on Sexual Abuse in the Catholic Church released its report detailing consistent disregard of survivors and the callous and horrifying "lack of outrage" from bishops and other Catholic leaders. What this report does not tell is the story of the priests who themselves are survivors of clerical abuse and their struggles.

At the age of forty-eight, Patrick C. Goujon, SJ, suddenly remembered what a priest had done to him, for four long years, beginning when he was seven years of age. Locked in denial for almost forty years, he finally spoke out. He thought he could then heal. Yet his whole life started falling apart. He questioned why his memory had been suppressed for such a long time. And he asked himself: How could I have chosen to become a priest myself? In *Precarious*, he tells the story of how he learned to survive the shock of this revelation and to live as a believer. His story is a healing journey and a path to finding support in spirituality to recover from child abuse.

PATRICK C. GOUJON, SJ, is a professor of theology and spirituality at Centre Sèvres, the Jesuit school of graduate theology in Paris; a fellow at Campion Hall–Oxford (UK); and the chief editor of the journal *Recherches de Science Religieuse*.

GERALD J. MCGLONE, SJ, is a senior research fellow at the Berkley Center for Religion, Peace, and World Affairs at Georgetown University. Previously, he was the chief psychologist and the director of counseling services at the Pontifical North American College in Rome.





QUESTION AND ANSWER WITH THE AUTHORS

How did you come to write this book?


Barry Harrelson: Growing up in the South and attending segregated schools in the 1950s and 60s, I knew little about the local Black schools and nothing of the Black communities' struggles to provide education for their children. As I studied the found school files, I realized that the breadth of the records offered an opportunity to tell a unique local history of segregated schools dating back to the Civil War.

Who are some of the key figures in the fight for educational equality in Loudoun County, Virginia?

The efforts of Gertrude Alexander, a Jeanes Fund Supervisor and force for social change, were critical in the founding of Douglass High School, the first high school building dedicated for Black students in Loudoun in 1941. She did it with the support of Charles Hamilton Houston of the national NAACP and a legendary Black educator from Richmond named Archie Richardson.

What is one thing described in the book that might surprise readers?

One of the biggest surprises was just how many obstacles the Black community had to contend with. A revealing example is the case of Douglass High School. The white government repeatedly ignored calls to build a modern high school building even though since about 1920 Black students had only the second floor of a rickety two-story frame structure built in 1883 as a grammar school, whereas whites had several high schools, the earliest dating to 1910. The Black community had to raise thousands of dollars to buy the land for Douglass, using income from pie sales and similar small efforts. Then, once the land was purchased, the white government insisted it be sold to them for \$1. Once the building was constructed in 1941, the Black community had to raise funds again for the furniture, making Douglass not only a monument to Black determination but also a massive symbol of white suppression.


Since the sixteenth century, Catholicism has contributed significantly to global connectivity. Except for the Philippines and Timor-Leste, Catholicism in Asia is, and will likely remain, a minority religion. For this reason, it can serve as a unique prism through which to look at the processes of globalization in Asia.

Asian Pacific Catholicism and Globalization demonstrates to scholars and students of Catholic history that the development of Catholicism in Asia and later in the Oceania-Pacific region is closely associated with three different phases of globalization. This book approaches the historical processes of globalization not as structural agencies or causal forces, but rather as the historical contexts that condition possibilities for human action and reaction in the world. The editors identify three distinct phases in the development of Catholicism in Asia and Oceania: early modern (sixteentheighteenth centuries), modern Western hegemony (1780s-1960s), and the contemporary (1960s-present). The book's contributors discuss the development of Catholicism in all the major countries of the region, including China, Japan, South Korea, the Philippines, Vietnam, India, and Australia.

JOSÉ CASANOVA is one of the world's leading scholars in the sociology of religion and a senior fellow at the Berkley Center at Georgetown University, where his work focuses on globalization, religions, and secularization. His best-known work, *Public Religions in the Modern World* (1994), has become a modern classic in the field.

PETER C. PHAN is the inaugural holder of the Ellacuria Chair of Catholic Social Thought at Georgetown University. He is the editor of *Theology Without Borders* (Georgetown University Press, 2022).



The Second Vatican Council invites dialogue about the common good as the set of economic, political, legal, and cultural conditions for human flourishing, whether as individuals or as communities. However, some contemporary Catholic authors jeopardize this dialogue by polarizing liberalism and the common good, interpreting the commitment to individual liberty as incompatible with commitment to the common good.

Human Dignity and Liberal Politics clarifies the meaning of the common good through the three lenses of Aristotelian practical philosophy, twentieth-century Catholic social thought, and political liberalism. It makes the case that embracing the common good does not entail a rejection of liberalism, but that a commitment to liberal politics is compatible with faithful adherence to the Catholic tradition. The book argues that liberal political philosophy is not only compatible with Catholic social teaching but may also be the most appropriate framework for communicating the richness of the Church's tradition today. Furthermore, accepting political liberalism can facilitate collaboration in political life between those who hold different worldviews and foster an enriched discussion of democracy, human rights, and religious liberty.

Students and scholars of Christian ethics and political philosophy will benefit from this response to the challenges of dialogue about the "common good" in the context of the resurgence of this topic.

Danko Šipka touches on the origins of the Slavic languages, their linguistic similarities and differences, word borrowing across them all, and the cultural importance of languages even within this family of languages.

Water, Whiskey, and Vodka will fascinate readers—whether or not they speak Slavic languages interested in the history and development of one or more Slavic languages. Writing from the Slavic linguistic tradition, where talking about language happens in the public sphere, he offers readers a deeper understanding of various Slavic cultural traditions and historical events as they are reflected in their languages.

DANKO ŠIPKA is a professor of Slavic languages and head of linguistics at Arizona State University, where he teaches in the School of International Letters and Cultures. He served as a senior linguist and consultant to numerous language industry companies. He has written thirty books, including *The Geography of Words* (2022) and *Lexical Layers of Identity* (2019).


